**WELCOME:** The member Clubs of the American Volkssport Association (AVA) in the Mid-America Region, which is comprised of the states of Kentucky, Ohio, Michigan, Illinois and Indiana, the Mid-America Regional Director (MARD) Mid-America Deputy Regional Director invite and welcome you to the 2026 Mid-America Walking Weekend/Conference to celebrate the AVA's 50<sup>th</sup> Anniversary. This walking weekend is comprised of four walking events. The first walking event is hosted by the Clubs of Ohio in Terre Haute, Indiana on Friday. The second and third walking events will be hosted by the Clubs of Michigan and Illinois in Charleston, Illinois, on Saturday morning and another walking event on Saturday afternoon at Fox Ridge State Park. The fourth walking event will be hosted by the Clubs of Indiana on Sunday in Casey, Illinois.

**WHAT ARE VOLKSSPORTS?** A Volksmarch is a non-competitive walking event. The walk is ten kilometers or 6.2 miles in length. Other Volkssporting events include swimming, biking, and skiing. These events are hosted by clubs in more than forty nations worldwide and the fifty states of the USA. The purpose of Volkssporting events is to encourage physical fitness, promote fellowship, and to enjoy the outdoors. Because these events are not contests of speed or endurance, you may participate at a pace that is safe, comfortable, and enjoyable. When Volkssporting events are sanctioned by the International Volkssport Verband (IVV), individuals may receive credit for event participation and/or distance. This credit is recorded in IVV Record Books, which presently cost \$6.00 each. After completing a pre-determined number of events and/or distance, your achievement will be recognized with a pin, patch, and certificate by the IVV. Further information will be available at the start/finish point.

**START/FINISH:** The Start/Finish Points are as indicated on pages 3 through 6 of this brochure and the event information published on the American Volkssport Association (AVA) website, [my.ava.org](http://my.ava.org). A link is provided for each event on pages 3 through 6 of this brochure.

**FEES:** Everyone is welcome. However, participants must register and pay a registration fee. The registration fee for ALL participants is \$4.00. In addition to the standard walk registration fee of \$4.00, there is a \$10.00 Fest Activity & Venue Fee to cover the costs of this Fest weekend. The fee will be charged and collected one time from each individual at the time of his or her registration, whether done through pre-registration or on-site registration. A 50% discount is available for the Fest Activity and Venue Fee if your pre-registration is received by February 2, 2026.

**IVV CREDIT:** Participants completing these events are eligible for IVV event and distance credits.

**AWARDS:** There is NO A-Award available for this and walking events.

**SWAG BAG:** For pre-registered participants, a nifty and useful swag bag will be prepared and available for pickup on site. The swag may be picked up Thursday evening per the information provided on Insert Page 1. Swag bags will also be available at all staffed Start/Finish Points. Meal tickets will be included in the contents of the swag bag. Swag bags will also contain other useful items.

**SPECIAL EVENT STAMPS:** All events qualify for the following AVA Challenge Programs: Centurion Achievement Challenge, Walking the USA A-Z, Walking the United States (50 States/51 Capitals) and IVV Americas. Qualifiers for other AVA Challenge Programs along the routes may be identified by the lead host club in the event detail found at [my.ava.org](http://my.ava.org).

**TRAIL DESCRIPTIONS:** The walk routes are described on pages 3 through 6 of this brochure and as published on the AVA website.

**SPECIAL NEEDS:** A special needs trail will be available upon request at each of the events.

**REFRESHMENT:** Water may be available at both start/finish points and any staffed checkpoints, if provided. It is recommended that participants carry some water with them along the routes, because of the possibly warm, if not hot, and humid weather that may be experienced in West Central Indiana and East Central Illinois during the month of June. Restrooms are available at the Start/Finish Point, or nearby, and may also be available along the routes.

**PRE-REGISTRATION:** All walking events are offered through the AVA Online Start Box and through pre-registration for this Fest activity. Pre-registration for the Fest activities is required for participation. Registration on-site is available only on the date and at the time that the walking event is featured, as denoted by a staffed Start/Finish Point. All participants must pay the Fest Event Activity and Venue Fee of \$10.

**REFUND POLICY:** NO refunds given.

**WEATHER IMPACT:** These events will be held rain, shine, or snow except in the case of extreme weather conditions posing a threat to life, limb and property.

**LODGING:** The Hilton Garden Inn of Mattoon is our current preferred lodging location. The hotel is also the site of our Welcome activity on the evening of Friday, June 19. At present we have block of twenty rooms (10X King Rooms and 10X Queen Rooms) available at \$135 per night for check-in on June 19 and checkout on June 21, which does include breakfast. The current cutoff date for these rooms is May 29. If the initial twenty rooms are filled and depending upon demand, the number of blocked rooms may be increased. **EVENT # 4**  
**SUNDAY, JUNE 21, 2026**  
**CASEY, ILLINOIS**  
**AVA Sanction: MA26/131638**

This event is open to everyone, though registration is required. The event is a Map Guided Walk through Historic & Notable Casey, Illinois, which has bragging rights for having the largest of many commonly used everyday items. The overall trail rating is 1-A, which is described below. Average walkers may complete a 10- kilometer route rated 1-A in about two hours to two and one quarter hours. This event is hosted by the Clubs of Indiana with the Three Rivers Strollers as the lead Club with the assistance of the Indiana Volkssports Association. **START/FINISH POINT:** Fairview Park, near the ASA Softball Hall of Fame, 704 East Monroe Avenue, Casey, Illinois 62420. Registration is open at the Start/Finish Point at 8 am (CDT) to 10 am. To accommodate finishers, the host Club may keep it available until 11 am. People who have registered for this event through the AVA Online Start Box (OSB) may do this anytime from dawn to dusk from June 17 through June 24.

**DISTANCES OFFERED:** 5 Km (3.2 miles) or 10 Km (6.2 miles)

**REGIONAL DIRECTOR GROUP GUIDED WALK:** Participants, who so desire, may link up with the Mid-America Regional Director and special guests at the Start Finish Point NO Later Than (NLT) 8:30 am CDT for a 10-K Group Guided Walk.

**TRAIL RATINGS:** 1-A (Scale of 1 to 5 references elevation gain with 5 being the most difficult. Scale A to E references type of trail with E being the most difficult). The five-kilometer route is rated 1-A.

**TRAIL DESCRIPTION:** All routes incorporate existing sidewalks and trails on properties administered by the City of Casey and its Department of Parks and Recreation. Portions of the routes may not be suitable for strollers or wheelchairs. Sidewalks may be uneven or cracked. Some steps may be encountered when beginning and completing the walk. Dogs are permitted but must be leashed and under the control of the owner, who is also responsible for cleaning up after their pet. Some facilities along the routes may ban pets' entry to the facility.

**RESTROOMS:** Will be available on site at Start/Finish or within a short walk and at some facilities along the routes.

**DIRECTIONS:** From Interstate I-70 Exit 129 to Illinois State Route 49 Southbound into Casey. At the intersection of IL-49 and Harrison Avenue TURN LEFT to head in an Easterly direction to Fairview Park. As you enter the Park, the Start Point can be identified on your right.

**EVENT # 1**  
**FRIDAY, JUNE 19, 2026**  
**TERRE HAUTE, INDIANA**  
**AVA Sanction: MA26/131746**

This event is open to everyone, though registration is required. The event is a Map Guided Walk through the historic downtown Terre Haute, Indiana, and the campus of Indiana State University. The overall trail rating is 1-A, which is described below. Average walkers may complete a 10- kilometer route rated 1-A in about two hours to two and one quarter hours. This event is hosted by the Clubs of Ohio with the Maumee Volkssporters as the lead Club. For detailed information on this event that is published on the AVA website, please use the following link:

**START/FINISH POINT:** Vigo County YMCA, 951 Dresser Drive, Terre Haute, Indiana 47807. Registration is open at the Start Finish point from 8 am (EDT) to 10 am. To accommodate finishers, the host Club may keep it available until 11 am. People who have registered for this event through the AVA Online Start Box (OSB) may do this anytime from dawn to dusk from June 17 through June 24.

**DISTANCES OFFERED:** 5 Km (3.1 miles) or 10 Km (6.2 miles).

**REGIONAL DIRECTOR GROUP GUIDED WALK:** Participants, who so desire, may link with the Mid-America Regional Director and special guests at the Start Finish Point NO Later Than (NLT) 8:30 am EDT for a 10-K Group Guided Walk.

**TRAIL RATINGS:** 1-A (Scale of 1 to 5 references elevation gain with 5 being the most difficult. Scale A to E references type of trail with E being the most difficult).

**TRAIL DESCRIPTION:** All routes incorporate existing sidewalks and trails on properties administered by the City of Terre Haute and its Department of Parks and Recreation. Portions of the routes may not be suitable for strollers or wheelchairs. Several high traffic intersections will be crossed using the available pedestrian signal. Dogs are permitted but must be leashed and under the control of the owner, who is also responsible for cleaning up after their pet. Some facilities along the routes may ban pets' entry to the facility.

**RESTROOMS:** Will be available on site at Start/Finish and some facilities along the route.

**DIRECTIONS:** From Interstate 70 (US 40) Exit 7 proceed in a Northerly direction on US 41, which may also be identified as US 150 or South Third Street. Stay in the left lane. At the intersection of Farrington Street TURN LEFT to proceed in a Westerly direction on Farrington. After crossing the intersection of Farrington and South First Street, Farrington becomes Dresser Drive. As you enter Fairbanks Park, you will see the YMCA on your left. Free parking is available within the Park.

**EVENT # 2**

**CHARLESTON, ILLINOIS**  
**AVA Sanction: MA26/131609**

This event is open to everyone, though registration is required. The event is a Map Guided Walk through Historic & Notable Charleston, Illinois and the campus of Eastern Illinois University. The overall trail rating is 1-A, which is described below. Average walkers may complete a 10- kilometer route rated 1-A in about two hours to two and one quarter hours. . This event is hosted by the Washtenaw Wanderers Volkssporting Club from Michigan and the Gateway Milers from Illinois. **START/FINISH POINT:** The East Pavillion at Morton Park, 1215 Division Street, Charleston, Illinois 61920. . Registration is open at the Start/Finish Point at 8 am (CDT) to 10 am. To accommodate finishers, the host Club may keep it available until 11 am.

**DISTANCES OFFERED:** 6 Km (3.75 miles) (Rated 1-A) or 10 Km (6.2 miles) (Rated 1-B).

**REGIONAL DIRECTOR GROUP GUIDED WALK:** Participants, who so desire, may link up with the Mid-America Regional Director and special guests at the Start Finish Point NO Later Than (NLT) 8:30 am CDT for a 10-K Group Guided Walk.

**TRAIL RATINGS:** 1-B (Scale of 1 to 5 references elevation gain with 5 being the most difficult. Scale A to E references type of trail with E being the most difficult). The six-kilometer route is rated 1-A.

**TRAIL DESCRIPTION:** All routes incorporate existing sidewalks and trails on properties administered by the City of Charleston, its Department of Parks and Recreation and Eastern Illinois University. Portions of the routes may not be suitable for strollers or wheelchairs. Sidewalks may be uneven or cracked. Some steps may be encountered when beginning and completing the walk. Dogs are permitted but must be leashed and under the control of the owner, who is also responsible for cleaning up after their pet.

**RESTROOMS:** Will be available on site at Start/Finish and along the routes.

**DIRECTIONS:** From Interstate I-57 Exit 190 take Illinois State Route 16 Eastbound to Charleston, which is also Charleston Avenue in Mattoon and Lincoln Avenue in Charleston. At the intersection of IL-16 (Lincoln Avenue) and Division Street TURN LEFT and locate a parking spot on the streets surrounding Morton Park.

**EVENT #3**  
**SATURDAY, JUNE 20, 2026**  
**FOX RIDGE STATE PARK, ILLINOIS**  
**AVA Sanction: MA26/131610**

This event is open to everyone, though registration is required. At present there are no gate entry fees at Illinois State Parks. However, there is a possibility that it may change by the time of this event. Check the Mid-America Facebook page for any change with respect to the gate entry fee issue. The event is a Map Guided Walk through the historic Embarras River Watershed in Coles County. Embarras River meanders to its confluence with the Wabash River. The overall trail rating is 3-B, which is described below. Average walkers may complete a 10- kilometer route rated 3-B in about two and one half hours to three hours. This event is hosted by the Washtenaw Wanderers Volkssporting Club from Michigan and the Gateway Milers from Illinois. **START/FINISH POINT:** Brick Pavillion at Fox Ridge State Park, 18175 State Park Road, Charleston, Illinois 61920. Staffed Start/Finish Point is open 2 pm (CDT) to 4 pm. . To accommodate finishers, the host Club may keep it available until 11 am.

**DISTANCES OFFERED:** 5 Km (3.1 miles) (Rated 2-B) or 10 Km (6.2 miles) (Rated 3-B).

**REGIONAL DIRECTOR GROUP GUIDED WALK:** Participants, who desire, may link with the Mid-America Regional Director and special guests at the Start Finish Point NO Later Than (NLT) 2:30 pm CDT for a 5-K Group Guided Walk.

**TRAIL RATINGS:** 3-B (Scale of 1 to 5 references elevation gain with 5 being the most difficult. Scale A to E references type of trail with E being the most difficult).

**TRAIL DESCRIPTION:** All routes incorporate existing trails on properties administered by the Illinois Department of Natural Resources. Portions of the routes may not be suitable for strollers or wheelchairs. The trails are unimproved (dirt with tree roots protruding through the surface and boulders) with significant elevation changes. Snakes may be encountered along the trails. Please exercise caution. Dogs are permitted but must be leashed and under the control of the owner, who is also responsible for cleaning up after their pet.

**RESTROOMS:** Will be available on site at Start/Finish and along the routes .

**DIRECTIONS:** From Morton Park TURN LEFT onto IL-16 (Lincoln Avenue) to proceed in an Easterly direction on IL-28. At the intersection of IL-16 and Illinois State Route 130, where you will see the Charleston High School on your left, TURN RIGHT to proceed in a Southerly direction on IL-130. Remain on IL-130 until you encounter the entry to Fox River State Park on your right. TURN RIGHT into Fox River State Park and follow the signage to the Brick Pavillion.
